GENERAL INFORMATION: This golf cart is rented by The Cart Store and is designed and fabricated for PLEASURE CRUISING ONLY. Any attempt of speeding, racing, jumping of these units or other reckless driving or driving under the influence of alcohol or drugs will result in the loss of deposit and you will be subjected to a potential lawsuit.

RENTAL RULES & REGULATIONS: THE PRIMARY RENTER OF GOLF CART **MUST BE** A MINIMUM OF 21 YEARS OLD WITH VALID DRIVERS LICENSE AND PROOF OF VALID AUTOMOBILE INSURANCE POLICY.

- A. Golf cart must be driven on town streets and authorized beach roads only.
- B. Golf carts must be returned with a full tank of fuel or be charged with a \$25.00 refuel fee. (initial) _____
- C. If golf cart is delivered, a fee of \$20.00 will be automatically charged to contract to cover fuel.
- D. Golf cart must be returned at the end of the agreed rental time period.
LATE FEES will be assessed at the rate of \$25.00 per half hour.
- E. Golf carts are not to be driven in or near the water—bays, boat docks, etc. Please allow 50 feet distance from water.
- F. Licensed drivers **ONLY** are permitted to operate the golf carts. Drivers must be a minimum age of 16 to operate the rental golf carts with a valid license.
- G. Any additional potential drivers who might drive the cart during the rental period **MUST** provide a valid drivers license, proof of insurance, and be at least 16 years of age and be an additional signer of this agreement.
- H. Lessee or authorized representative must be present at time of delivery and pickup of rental cart(s).

Renters agree that they are solely responsible for any and all damages while the cart is in their care, custody and control and warrant that they have inspected said vehicle at time of rental and affirm they are familiar with the operation of the golf cart in regard to, but not limited to steering, braking and speed control device (accelerator). Not withstanding anything to the contrary, I hereby authorize The Cart Store to file any and all documents with my insurance carrier to facilitate the collection of any and all sums due to The Cart Store for any accident or event which causes damage to the property.

Renter acknowledges they have inspected the golf cart and have noted on the form any damage or scratches seen on the cart and further acknowledges any damage or scratch not noticed is subject to damage costs as described in the paragraph above.

Should the golf cart enter a body of water Bay or Surf during the contract agreement period, Renter is subject to being charged the full purchase price of the golf cart at an average replacement cost of \$8,500.00 to 12,500.00.
